This comes after the resounding success of the 2013 Indaba, where your contribution confirmed your commitment to guide us in achieving the mandate bestowed upon us by the Government of South Africa.

This year NLB celebrates 15 years of existence, and has since inception, distributed over R 18 billion to good causes for social upliftment from a portion of the proceeds of lotto ticket sales. This is also our annual flagship event where we celebrate our successes over the past year.

This year's event, themed "**CELEBRATING 20 YEARS OF THE CIVIL SOCIETY MOVEMENT IN SOUTH AFRICA**" will be the third, after successful events hosted by the NLB in 2011 and 2013.

- Audit all the infrastructure and beneficiaries' assets acquired through the NLDTF-funded projects.
- Develop and implement norms and standards for grant funding.
- Endorse and align NLDTF-funding with the National Development Plan with focus on poverty alleviation and job creation.
- Facilitate a process of mentoring and coaching of new organisations by established ones;
- And; Absorb about 1000 graduates through projects funded by NLDTF.

The 2014 Indaba will serve as an opportunity to share our successes in line with last year's resolutions, and reflect on the past 20 years of service delivery, 15 of which also chronicle the impact of the NLB as a Catalyst for Social Upliftment. Indeed, we too at the NLB have a good story to tell.

The invitation is also extended to the Presidency, Minister of the Department of Trade and Industry and other cabinet ministers, especially those that are cited in the National Lotteries Act, namely Social Development, Arts & Culture, and Sports and Recreation, along with all premiers and Provincial and local stakeholders including NLB beneficiaries. Our work at the NLB cuts across these sectors as social upliftment takes place in various ways that contribute to nation building.

Your presence at the Indaba will aid us in charting the path forward as we mobilise our projects to make a difference in our communities, and redress the legacy of the past.
