## 10. 1. ISAKHIWO NEMISEBENZI

IKhomishani Kazwelonke Yelotho (“iKhomishani”) ingumgwamanda osemthethweni, olawulayo owasungulwa ngokoMthetho Welotho wonyaka we-1997 (uMthetho wama-57 wonyaka we-1997) (“uMthetho Welotho”).

Ikhomishini isebenzisa igunya jikelele ezindabeni zehhovisi leKhomishini (i-NLC) kanye neze-National Lottery Distribution Trust Fund (“i-NLDTF”) IKhomishini, ngokubambisana noKhomishini, inomthwalo wokuziphatha jikelele imisebenzi yayo kanye nemisebenzi ye-NLDTF kanye nayama-Ejensi Okusatshaliswa (Distributing Agencies) (“ama-DA”).

Imisebenzi yeKhomishani njengoba ichaziwe eMthethweni Welotho wonyaka we-1997 njengabo ilandela:

- Ukweluleka uNgqongqoshe ngamaphesenti ezimali ezizokwabiwa ngokwesahlukwana sama26(3) soMthetho Welotho;
- Ukweluleka uNgqongqoshe ngokuphumelela kweqoqomthetho eliphathelene namalotho kanye nezinto ezisekelayo;
- Ukweluleka uNgqongqoshe ngokusungula kanye nokuseqaliswa kohlelo lokubhekela umphakathi maqondana namalotho;
- Ukuphatha nokutshala izimali ekhokhelwe iKhomishini ngokuhambisana noMthetho Welotho;
- Ukwenza imisebenzi engeziwe ngokuphathelene namalotho njengoba uNgqongqoshe engayabela iKhomishini;
- Ukwenza amalungiselelo njengoba echazwe kwimvume yokuvikelwa kwezimali zomklomelo nezimali zokusabalalisa; futhi
- Ukweluleka uNgqongqoshe nganoma yiluphi udaba oluphathelene neLotho Kazwelonke kanye namanye amalotho noma nganoma yimuphi omunye umdanti uNgqongqoshe angadinga ngalo iseluleko seKhomishini.
