1. BACKGROUND

The National Lotteries Commission (NLC) is a public entity established by Lotteries Act No. 57 of 1997 as amended to regulate the South African lotteries industry. The functions of the Commission can be divided into two categories, namely “regulation of National Lottery and other Lotteries” and “administration of the National Lottery Distribution Trust Fund (NLDTF)”.

Chapter eight (8) of the Minimum Information Security Standards (MISS), 1996, requires of the NLC as a public entity to implement measures to control the access to the NLC premises.

The NLC invites suitably qualified and experienced bidders to submit proposals for provision of a security services. In line with the requirements of the Public Finance Management Act (PFMA) No. 1 of 1999 and Treasury Regulations, the NLC seeks to engage the services of a duly qualified bidder

2. PURPOSE

The purpose of the terms of reference (TOR) is to appoint a suitably qualified and experienced bidder to provide security services to the NLC for a period of three (3) years.

3. OBJECTIVES

The primary objective of this TOR is to appoint a suitable bidder to provide twenty-four (24) hour security services to the NLC Head Office (Pretoria).

4. SCOPE OF WORK

The scope of work entails the following:

4.1 Duties

- Enforcement of Section two (2) of the Control of Access to Public Premises and Vehicles Act, 1985 (Act 53 of 1985);
- Responsible for access control, guarding of premises, patrolling of premises;
- Escorting of VIPs & bidders;
- Protection of personnel, property, visitors, personal belongings, NLC assets and NLC staff's personal belongings;
- Protection of visitors and their personal belongings;
- execution of other security functions;
- To record details of all individuals entering and exiting NLC premises and further record all incidents in an occurrence register and report such incidents to the Facilities; and
- Enforce NLC security policy, systems and procedures.

4.2 Security measures for conformance to provision of MISS:

- Access Control: Manning the physical systems;
- The furnishing of identification; the declarations concerning hazardous objects, contents of any suitcase, briefcase, handbag, bag, etc.; electronic examination; and
- The handing over of any object for examination or custody that may be required as a prerequisite for effective access control.

4.5 Uniform

4.5.1 Security officers must always be clad in their corporate uniform i.e. formal shirt and pants; tie and/or blazer; appropriate shoes; and

4.5.2 Coveralls/jumpsuits and/or combat clothing will not be accepted.

5. Essential requirements

In addition to other requirements in this document, the following will also be required:

- 5.1 The bidder must meet all the requirements of the (Private Security Industry Regulatory Authority Act (PSIRA), Act 56 of 2001. PSIRA compliance audit on the bidder shall be conducted at least once in twelve (12) months by PSIRA Inspectors. It is the bidder's obligation to invite PSIRA for such inspections and submit audit reports to the NLC.
- 5.2 Security officers must be in possession of valid PSIRA certificates. A certified copy of the PSIRA certificates must be included in the bid submission. Security Officers must display valid PSIRA cards when on duty at the NLC.
- 5.3 Security officers should demonstrate good proficiency in English.
- 5.4 Security officers must practice professionalism when on duty at the NLC and adhere to the NLC Security Policy, Systems and Procedures.
- 5.5 The bidder and security officers must always respect the Rules, Laws, Regulations and Constitution of South Africa.
- 5.6 Security officers to work with the CCTV system must have the relevant skills, knowledge and expertise to monitor and analyze the CCTV Surveillance System. Proof of training will be requested.
- 5.7 All Grade C security officers must be capable to operate and analyze X-RAY scanner machines. Proof of training will be requested.

- 5.8 Bidder to render services at NLC must provide a health and safety plan and bidder code of conduct and ensure adherence by all security officers.
- 5.9 Bidder to render services at NLC must provide a backup communication system to be used during emergency for direct contact with the base station (in the form of cell phones, radios etc.).
- 5.10 Criminal records check and security screening will be done on both the Bidder Director(s) and security officers deployed at the NLC at least twice in a year. If found to be involved in criminal activities, such directors/officers will not be allowed to work at the NLC.

6. DELIVERABLES

- Provide a twenty-four (24) hour, seven days a week security services at NLC Head Office.
- The appointed service provider is expected to provide incident reports, day to day Security Operational reports.

7. REPORTING REQUIREMENTS

The bidder will report to Facilities Department.

8. DURATION OF THE PROJECT

The expected duration of the project is three (3) years after the signing of a Service Level Agreement (SLA).

9. COMPULSORY BRIEFING SESSION

No compulsory information session for this bid.

10. EVALUATION CRITERIA

The NLC will evaluate all proposals in terms of the Preferential Procurement Regulation of 2001 and Preferential Procurement Policy Framework Act. No. 5 of 2000 (PPPFA). A three (3) phase evaluation criteria will be considered in evaluating the proposals, being:

10.1 Phase 1: Pre - Qualification Criteria (Mandatory Requirements)

Bidders must submit all the mentioned below requirements. The following mandatory requirements must be met to qualify for this bid:

- Original signed standard bidding documents (SBD Forms). It is required that the bidder provide correct information and declaration (where possible) in the SBD Forms.
- In the event of the bidder being in a joint venture, joint venture agreement must be submitted (*where applicable*).
- Bidder registration certificates (CK).
- Bidders must have a minimum B-BBEE status level of contributor of 1.
- Proof of full accreditation with the Private Security Industry Regulator Authority (PSIRA). Please submit a certified copy of valid membership certificate.

The following is a non-mandatory requirement and should be submitted:

- Central Supplier Database (CSD) Summarized Report. Please submit the current CSD Report.

10.2 Phase 2: Functional/Technical Evaluation

Only bidders that have met the pre-qualification criteria will be evaluated for functional evaluation. In this phase the evaluation will be based on the bidders' responses in respect of the bid proposal (evaluated on the minimum functional specifications). Prospective bidders who score a minimum of 70% points or more will be considered for the next phase 3 (Price and B-BBEE status level contributor).

The bidder is required to provide three (3) contactable client references where its services can be verified. References should be presented in a form of a written letter on an official letterhead from clients where similar services have been provided and may not be older than two (2) years. Attention should be given to resources of the organization and/or individuals, financial standing of the bidder. Bidders must be able to provide with proven track records in providing similar services. Certified copies of bidder and Individual PSIRA Certificate, PSIRA Letter of Good Standing	20%
3. Capacity and ability to deliver the security services	
The bidder is required to demonstrate their bidder's suitability with respect to its capacity/ ability to execute and deliver on the project, based on the supplier's track record, of same/similar (previous) work having been undertaken within the scope and scale of this work. The bidder profile must also contain the entity's organizational structure, a staff organogram,	30%

as well as a profile of core staff, their experience and achievements. Audited financial statement/signed - off statement.	
4. Project plan/ Methodology	
<p>The service is required to provide a detailed plan depicting how the services will be delivered to the NLC. Attention should be given to the following:</p> <ul style="list-style-type: none"> • How the work will be managed; • Process and work flows within the firm; • How the firm will deal with crisis management; • Recourses; and • Reporting lines between the bidder and NLC in terms of contractual obligations. <p>Site inspection to be conducted. Maximum of 20% points for demonstration during site inspection. 11. GENERAL GUIDELINES

11.1 Submission Instruction

The bid should be ***hand delivered to the address specified below*** in ***six (6) sets each.***

One original plus five (5) copies of the proposal (i.e. six (6) sets in total) should be clearly marked:

“PROVISION OF SECURITY SERVICES FOR THE NATIONAL LOTTERIES COMMISSION, REFERENCE NUMBER: NLC/2018 - 18”

Please note that the Technical and Financial proposals should be submitted in two (2) separate sealed envelopes.

Bidders are requested to indicate on the cover of each document whether it is the original document or a copy.

Take note of the following:

- No costs have been prescribed for the Bidding Document;
- All proposals **must** be costed in South African Rand, inclusive of VAT;
- If the bid does not include all the information required, or is incomplete, this will mean non-compliance and therefore invalidate the bid;
- Any submission received after the deadline will not be considered; and
- The costing must remain valid and open for evaluation for a period of at least six (6) months from the time of submission.

11.2 Late bids

Bids received late shall not be considered. A bid will be considered late if it arrived one second after 11:00 am or any time thereafter. The tender (bid) box shall be locked at exactly 11:00 am and bids arriving late will not be considered under any circumstances. Bidders are therefore strongly advised to ensure that bids are dispatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

The official Telkom time (Dial 1026) will be used to verify the exact closing time.

11.3 Costs to be borne by bidders

All costs and expenses incurred by the bidders in any way associated with the development, preparation and submission of responses and providing any additional information required by the NLC, will be borne entirely and exclusively by the bidders.

11.4 No legal relationship

No binding legal relationship will exist between any of the bidders and the NLC until the execution of a signed contractual Service Level Agreement (“SLA”). The TOR document will not form part of any such contract or arrangement.

11.5 Evaluation of offers

Each bidder acknowledges and accepts that the NLC may, at its absolute discretion, apply selection criteria specified in this document for the evaluation of proposals for short listing/ selecting the eligible bidder(s).

11.6 Format of your proposal

The proposal should be presented in two sections i.e. Technical Proposal and Financial Proposal.

11.6.1 Technical proposal format

Bidders should submit technical proposal according to specifications provided in the TOR which must reflect the exact requirements and quantity required in paragraph 4.

11.6.2 Technical approach

- a) The bidder should demonstrate adherence to the TOR by elaborating on the services required and demonstrating whether the proposed proposal meets the requirements.

- b) Bidders should indicate how the kiosks will be delivered to different Provincial Offices.
- c) The proposal must include a project plan and timeframes.

11.6.3 Bidder experience

Bidders are required to provide proof that they have previously delivered similar services. Letters of reference from at least three (3) contactable referees must be submitted.

12. STANDARD REQUIREMENT OF THE BID

12.1 Disclosures

The bidder must disclose:

- a) If they are or have been the subject of any proceedings or other arrangements relating to bankruptcy/ insolvency.
- b) If they have been convicted of, or are the subject of any proceedings, relating to:
 - A criminal offence or other offence, involving the activities of a criminal nature in its organisation or found by any regulator or professional body to have committed professional misconduct;
 - Corruption, including the offer or receipt of any inducement of any kind in relation to obtaining any contract with any contracting authority; and
 - Failure to fulfil any obligation in any jurisdiction relating to the payment of taxes and other legal obligations.
- c) If a bidder or related bidder or any individual discloses details of any previous misconduct or complaint, the NLC will seek an explanation and background details from them. At the sole discretion of the NLC, an assessment as to whether the bidder

will be allowed to continue to the next phase of the evaluation phase will then be made.

- d) Disclosure extends to any bidder in the same group of the bidder, including but not limited to parent, subsidiary and sister companies, companies with common shareholders (whether direct or indirect) and parties with whom the bidder is associated in respect of this tender.

12.2 Disclaimer

12.2.1 The NLC reserves the right not to appoint a bidder.

12.2.2 The NLC may appoint more than one bidder.

12.2.3 The NLC also reserves the right to:

- a) Award the contract or any part thereof to one or more bidders;
- b) Reject all bids;
- c) Decline to consider any bids that do not conform to any aspect of the bidding requirements;
- d) Request further information from any bidder after the closing date for clarity purposes;
- e) Cancel this tender or any part thereof at any time; and
- f) Should any of the above occur, it will be communicated in writing to the bidders.

12.3 Confidentiality

- a) Bids submitted will not be revealed to any other bidders and will be treated as contractually binding;
- b) All information pertaining to the NLC obtained by the bidder as a result of participation in this RFP is confidential and must not be disclosed without written authorisation from the NLC; and
- c) The successful bidder will be expected to sign a SLA with the NLC.

12.4 Disqualification

- a) Any form of canvassing/lobbying/influence regarding the short listing will result in disqualification;
- b) Any non-disclosure of any other information pertaining to this bid will result in disqualification;
- c) Non-compliance with the bid requirements will invalidate the bid; and
- d) Non-compliance with all the applicable Acts, Regulations and by-laws will result in the disqualification of the bid.

12.5 Prices

- a) All services' pricing should be inclusive of all taxes etc. and payment shall be made in South African Rand.
- b) Bidders to provide with the monthly security rate for all human resources that will be providing services to NLC. Bidders are further expected to provide with the total amount for the three (3) year security services for the eight (8) security officers required. The total amount proposed will be utilised for financial evaluation.
- c) The NLC may require a breakdown of prices on any of the items priced and the bidders are to provide same without any additional cost and also provide a "Pricing Grid" or "Transaction Fee Schedule".

12.6 Prices adjustments

Prices submitted for this bid will be regarded as non-firm subject to the following price adjustments:

- a) Annual price adjustment; and

- b) Application for price adjustments must be accompanied by documentary evidence in support of any adjustment on annual basis.

12.7 Payment terms

- a) The NLC undertakes to pay valid tax invoices in full within thirty (30) days from statement date for services rendered;
- b) All supporting documents for services rendered should be submitted together with the tax invoices by the twentieth (20th) of every month;
- c) Valid Tax Invoices for all services rendered are to be submitted to the Chief Financial Officer (CFO) at the NLC's Finance Division at the address on page 2 above or may be sent through an email to the following email address:

12.8 Validity

- a) A proposal shall remain valid for hundred and twenty (120) days after the closing date of the submission for proposals. A proposal which is valid for a shorter period may be rejected by the NLC for non-responsiveness.
- b) In exceptional circumstances, the NLC may solicit the bidder's consent to an extension of the period of the validity of the bid. The request and responses thereto shall be made in writing. A bidder that has been granted the request will neither be required nor permitted to modify the proposal.

12.9 Signatories

All responses to this RFP should be signed off by the authorised signatories of the bidder.

13. SPECIAL TERMS AND CONDITIONS

- a) The NLC reserves the right to accept or reject any submission in full or in part, and to suspend this process and reject all proposals or part thereof, at any time prior to the awarding of the contract, without thereby incurring any liability to the affected bidders;
- b) This bid and the contract will be subject to the General Conditions of Contract issued in accordance with Treasury Regulation 16A published in terms of the PFMA. The special terms and conditions of contract are supplementary to that of the general conditions of the contract;
- c) Where, however, the special conditions of contract are in conflict with the general conditions of contract, the general conditions of contract will prevail.
- d) The NLC is the sole adjudicator of the suitability of the venue for the purpose for which it is required. Therefore, the NLC's decision in this regard will be final.
- e) No bids sent by the facsimile or email will be accepted.
- f) Bids must only be submitted at the NLC Head Office Tender Box in Pretoria by the specified date and time.
- g) Bidders are welcome to be present at the opening of bids.
- h) The annexures are part of the bid documentation and must be signed by the bidder and attach to the bid document.
- i) The bid forms must not be retyped or redrafted but copies may be used. Additional offers may be made but only photocopies of the original documents. Additional offers/submissions are regarded as separate and must be treated as such by the bidder. The inclusion of various offers as part of a single submission in one envelope is not allowed and will not be considered. Additional bid offers must be submitted separately in separate sealed envelopes.
- j) The original valid Tax Clearance Certificate should be submitted together with the completed bid.
- k) Failure to comply with the above-mentioned conditions will invalidate the bid.
- l) Certified copies of the bidder registration documents or proof of ownership of the bidder or agency i.e. Shareholders Certificates.

- m) Certified copy of B-BBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor approved by IRBA or an Accounting Officer as contemplated in the CCA must be submitted.

14. OTHER CONDITIONS:

- i. Only bidders who obtain at least 70% under Functional/Technical Evaluation will be considered for further evaluation on phase 2.
- ii. Bidders are further requested to provide separate financial and technical proposals.
- iii. Bidders are requested to provide a clear agreement regarding joint venture/consortia. The percentage involvement of each bidder in the joint venture agreement should be indicated on the agreement. A trust, consortium or joint venture must submit a consolidated B-BBEE Status Level Verification Certificate for every separate bid.
- iv. Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims.
- v. A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- vi. A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
- vii. Fraudulent practices shall result in immediate disqualification.
- viii. NLC is under no obligation to accept any bid and reserves its right not to proceed with the appointment of any bidder that responded to the invitation to submit proposals, for whatever reasons it may consider appropriate.
- ix. Bidders are required to submit current and valid original or certified B-BBEE Certificate from SANAS or IRBA accredited verification agencies or proof of

exemption from registered auditors. (Failure to submit a certificate will result in scoring 0 for B-BBEE.)

15. PRESENTATIONS/SITE VISITS

- 15.1 Shortlisted bidders may be required to do a presentation and/or question and answer session.
- 14.2 The NLC may also conduct site visit/inspection.

16. CLARIFICATIONS / ENQUIRIES

Telephonic request for clarification will not be considered. Any clarification required by a bidder regarding the meaning or interpretation of the Terms of Reference or any other aspects concerning the bid is to be requested in writing (letter, facsimile or e-mail) from the below contact persons.
