ON FINANCE FOR NON-FINANCE OFFICIALS TRAINING

SECTION 1: BACKGROUND, OVERVIEW AND SCOPE REQUIREMENTS

1. INTRODUCTION

The National Lotteries Commission (NLC) was established in terms of the Lotteries Act No. 57 of

1997, as amended (Lotteries Act) to regulate the National Lottery as well as other lotteries and

societies.

The NLC has undergone a transition that was underpinned by changes that brought a new dawn of

rebuilding and restoring the integrity of the organisation. Earlier in 2023/24 financial year, the new

Commissioner and new Board members were appointed to steer the ship into a new direction. The

Department of Trade, Industry and Competition (dtic) as the shareholder also introduced the ministerial

impact targets, which has a huge direct and indirect impact on the Strategic Plan of the organisation.

The NLC employees are required to comprehend the financial methodologies in accordance with the

South African Standards of Generally Recognized Accounting Practice and it is the requirement of the

Public Finance Management Act of South Africa, 1999 (Act No.1 of 1999).

The other elements to be addressed are aligned to the NLC business operating model which is detailed

below. The training will therefore be required to be customized to deal with the NLC business operating

model as it relates to the interpretation of financial information.

Grant Funding Value Chain Process

Operations - Grant Funding

a) Calls for applications

This process includes research, creation of focus areas and publication. This part does not need

any financial management capabilities.

b) Application receiving

This part of the process requires CLOs to have some understanding of a complete and compliant

financial statement as per industry standard. They will also have to be able to pick up

discrepancies with the submitted financial statement.

c) Assessment: Pre-Adjudication Visit and Desktop

This part of the process requires competency to analyze financial statements (and or financial records not limited to budgets, quotations, business plans, etc.) in terms of compliance, completeness, interpretation, and identification of discrepancies from what is on the ground and what the financial statements outline. In addition, this part of the process also requires an understanding of accounting auditors' reports content as well as which reports come with type of Accounting Officer. It also requires a deeper understanding of different reports, level of associated assurance and what it means for the potential funder. Based on the assessment of AFS and the outcome of the pre-adjudication visit, an assessor must be able to gauge the financial capability of the organizations and make recommendations for improvement. The assessor must be able to identify fraudulent or misrepresented financial statements or records (invoices, quotations, bank statements, etc). Assessors must, using the financial statements, be able to determine the financial capability and viability of the organization making an application.

- d) Quality Assurance and Adjudication: The same level of understanding outlined in 3 above is required.
- **e) Approval for Adjudication:** This part is done by the Provincial Manager and needs the same level of understanding outlined in 3 above.
- **f) Adjudication:** This part is done by the Distributing Agencies and needs the same level of understanding outlined in 3 above.

g) Post Adjudication Monitoring

This process has two parts, which are progress report review as well as monitoring visits. It needs the same level capability as the one outlined in 3 above.

The request for quotations (RFQ) seeks to appoint a service provider to train the NLC employees on Finance for Non-Finance Officials Training.

2. BACKGROUND

The NLC has undergone a transition that was underpinned by changes that brought a new dawn of rebuilding and restoring the integrity of the organisation. Earlier in 2023/24 financial year, the new Commissioner and new Board members were appointed to steer the ship into a new direction. The Department of Trade, Industry and Competition (dtic) as the shareholder also introduced the ministerial impact targets, which has a huge direct and indirect impact on the Strategic Planof the organisation.

During 23/24 financial year skills audit exercise was conducted for the NLC employees, this resulted in

skills audit gaps that were identified as well as recommendations being made on how to close those gaps.

Finance for Non-Finance Managers was one of the training interventions recommended as part of reskilling and upskilling NLC employees which will assist in identifying and closing the gaps.

HCM designed a Learning and Development (L&D) plan that will be used in implementing the L&D priorities training interventions

3. OBJECTIVE

The NLC is seeking to appoint a competent and experienced service provider to facilitate Finance for Non-Finance Managers training, to be conducted during working days, at the 2 weeks after the service provider appointment.

The objective is to provide financial literacy skills training for the National Lotteries Commission (NLC) employees with a focus on project management, monitoring & evaluation, assessment of progress report. The training should be compatible and customized to the NLC, which will include the following:

- Incorporation of financial management data into strategic business decision-making.
- Demonstration and comprehension of the key concepts of managerial finance.
- Interpretation of financial statements.
- The NLC employees' comprehension of financial management needs and the impact of financing decisions.
- The knowledge of financial management tools within operational and strategic business processes.
- Drafting of budgets according to the NLC Operational Plan
- · Description and preparation of financial forecasts
- Supervising financial management.
- Assessments formative assessment (during training), summative assessment (building the Portfolio of Evidence)

4. SCOPE OF WORK

The service provider will be responsible for the following tasks as per the process-flow depicted herein:

- Demonstrate the essence of key finance and accounting principles, flexibility, scalability, extendibility and multitenancy of the system for future expansion.
- Ability to differentiate between Finance and Accounting

- Clarity on financial analysis of the financial statements
- Linking Budget Plans to the Operational objectives
- Demonstrating Financial Performance Measurements
- Implementation of corrective measures
- Clarity on how to monitor expenditure reports
- An analysis of the financial information, that includes bank statements, invoices, financial statements, quotations received from the beneficiaries.
- Provide general/basic accounting and finance principles
- Demonstrate, through a detailed proposal outlining a clear methodology that has the necessary skills, competencies, and experience to undertake this assignment.
- Provide evidence (including contactable references) of previous experience in implementing Finance for Non-Finance Managers Training course.
- Demonstrate that it has an intimate understanding of the research environment and be willing to tailor-make and customize the system to suit NLC needs.
- Implementation of the Finance Management training solution
- Partner with NLC for the duration of the contract to ensure optimal utilization and business impact.

5. DELIVERABLES

The appointed service provider is expected to deliver the following:

- Describe financial management terminology, concepts and principles
- Apply various financial planning techniques such as budgeting, cash-flow projections, cost benefit analysis, variance analysis and cost management
- Analyse and interpret financial management statements, records and reports such as the balance sheet, income and expenditure statement, budget, cash flow projection, variance analysis and assets register
- Describe valuations and credit management principles and processes
- Explain how financial decisions are arrived at.
- Give the basic principles of sound business investment decisions
- Appreciate financial principles of accountability, cost effectiveness, cost efficiency and value for money
- Apply ratio analysis of financial statements and appreciate the advantages and limitations of ratio analysis
- Describe financial management success and failure factors

6. DURATION OF THE E-LEARNING PLATFORM

The total duration of this proposed implementation of the training should be for a minimum of 2 days per training group. Provision of Training Services to 75 NLC Employees on Finance for Non-Finance Officials. Training will be for 2 Days per group, divided into 2 groups as follows:

• Group 1: 37 Employees & Group 2: 38 Employees.

- **1.** Terms and conditions of Request for Quotation
- 1.1 This document may contain confidential information that is the property of the NLC.
- 1.2 No part of the contents may be used, copied, disclosed, or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFQ without prior written permission from the NLC.
- **1.3** All copyright and intellectual property herein vests with the NLC.
- **1.4** Late and incomplete submissions will not be accepted.
- **1.5** No services must be rendered, or goods delivered before an official NLC PurchaseOrder form has been received.
- **1.6** This RFQ will be evaluated in terms of the 80/20 preference point system, where80 is price and 20 is special goal.
- **1.7** Suppliers are required to register on the Central Supplier Database at www.csd.gov.za.
- **1.8** Suppliers must provide their CSD registration number (and attach a CSD Registrationreport) and ensure that their tax matters are compliant.

- **1.10** Any supplier who has reasons to believe that the RFQ specification is based on aspecific brand must inform the NLC via the email addressed in 1.9.
- 2. General rules and instructions
- 2.1 News and press releases
- 2.1.1 Bidders or their agents shall not make any news releases concerning this RFQ or the awarding of the same or any resulting agreement(s) without the consent of, and thenonly in co-ordination with, the NLC.
- **2.2** Precedence of documents
- 2.2.1 This RFQ consists of a number of sections. Where there is a contradiction in terms between the clauses, phrases, words, stipulations, or terms and herein referred to generally as stipulations in this RFQ and the stipulations in any other document attached hereto, or the RFQ submitted hereto, the relevant stipulations in this RFQ shall take precedence.
- 2.2.2 Where this RFQ is silent on any matter, the relevant stipulations addressing such matter, and which appear in section 217 of the constitution of the republic shall take precedence. Bidders shall refrain from incorporating any additional stipulations in its proposal submitted in terms hereof other than in the form of a clearly marked recommendation that the NLC

may in its sole discretion elect to import or to ignore. Any such inclusion shall not be used for any purpose of interpretation unless it has been so imported or acknowledged by the NLC.

It remains the exclusive domain and election of the NLC as to which of these stipulations are applicable and to what extent. Bidders are hereby acknowledging that the decision of the commission in this regard is final and binding. The onus to enquire and obtain clarity in this regard rests with the Bidder(s). The Bidder(s) shall take care to restrict its enquiries in this regard to the most reasonable interpretations required to ensure the necessary consensus.

2.3 Preferential procurement reform

2.3.1 The Commission supports B-BBEE as an essential ingredient of its business. In accordance with government policy, the NLC insists that the private sector demonstrates its commitment and track record to B-BBEE in the areas of ownership (shareholding), skills transfer, employment equity and procurement practices (SMME Development) etc.

2.4 Language

2.4.1 Bids shall be submitted in English.

2.5 Gender

2.5.1 Any word implying any gender shall be interpreted to imply all other genders.

2.6 Headings

2.6.1 Headings are incorporated into this RFQ document and submitted in response thereto, for ease of reference only and shall not form part thereof for any purpose of interpretation or for any other purpose.

2.7 Occupational Injuries and Diseases Act 13 of 1993

2.7.1 The Bidder warrants that all its employees (including the employees of any sub- contractor that may be appointed) are covered in terms of the Compensation for Occupational Injuries and Diseases Act 13 of 1993 and that the cover shall remain inforce for the duration of the adjudication of this RFQ and/ or subsequent agreement. the commission reserves the right to request the Bidder to submit documentary proof of the Bidder's registration and "good standing" with the Compensation Fund, or similar proof acceptable to the commission.

2.8 Processing of the Bidder's Personal Information

2.8.1 All Personal Information of the Bidder, its employees, representatives, associates and sub-contractors ("Bidder Personal Information") required under this RFQ is collected and processed for the purpose of assessing the content of its tender proposal and awarding the

- bid. The Bidder is advised that Bidder Personal Information may be passed on to third parties to whom the commission is compelled by law to provide such information. For example, where appropriate, the commission is compelled to submit information to National Treasury's Database of Restricted Suppliers.
- 2.8.2 All Personal Information collected will be processed in accordance with POPIA and with the commission Data Privacy Policy.
- 2.8.3 The following persons will have access to the Personal Information collected:
- 2.8.3.1 The commission personnel participating in procurement/award procedures; and

- 2.8.5 In signing this document, the Bidder consents to the use of its Personal Information for the purposes as specified in section 2.9.1 above.

- **4.1** The Commission requires a validity period of 90 Days [from closing date]against this RFQ.
- **4.2** Bidders are to note that they may be requested to extend the validity period of their bids, on the same terms and conditions, if the internal evaluation process are not finalized within the validity period.
- 5. National Treasury's Central Supplier Database

- **5.1** Bidders are required to self-register on National Treasury's Central Supplier Database(CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information.
- **5.2** The Commission may not award business to a bidder who has failed to register on the CSD.
- **5.3** Only foreign suppliers with no local registered entity need not register on the CSD.

- **6.** Confidentiality
- **6.1** Bids submitted for this Request for Proposals will not be revealed to any other biddersand will be treated as contractually binding;
- **6.2** The Commission reserves all the rights afforded to it by the POPIA in the processing any of its information as contained in Bid Proposals.
- 6.3 The Bidder acknowledges that it will obtain and have access to personal information of The NLC and agrees that it shall only process the information disclosed by the NLCin terms of this bid award and only for the purposes as detailed in this RFP and in accordance with any applicable law.
- **6.4** The Bidder shall notify the NLC in writing of any unauthorized access to personal information and the information of a third party, through cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such.

7. Communication

- **7.2** In the interest of fairness and transparency the NLC's response to such a querymay be made available to other bidders.
- **7.3** It is prohibited for bidders to attempt, either directly or indirectly, to canvass any officeror employee of the NLC in respect of this RFQ between the closing date and the dateof the award of the business.
- **7.4** Bidders found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

8. Supplier Performance

8.1 The NLC conducts regular performance reviews inaccordance with the requirements for the classification of the contract and orstakeholder by making use of supplier evaluation forms. The evaluation is conducted against the deliverables or scope of the contract with a minimum of an annual review done for contracts longer than a year and a review at completion of contract

for those contracts less than a year.

- **8.2** Ad-hoc performance reviews shall be conducted where non-performance is identified outside the review period.
- **8.3** Non-performance will be addressed with at least a formal letter advising specificnon-performing areas and stating remedial action/s required within specific time frames. Non-adherence to remedial actions shall lead to escalating performance management actions.

Submissions must be prominently marked with the full details of the tender namely Bidder's Name, Tender No and Tender Title.

Tender submissions received after submission date and time will be declared late and will not be accepted for consideration by the NLC.
