
### 2. General rules and instructions

- 2.2 Precedence of documents
- 2.2.1 This RFQ consists of several sections (see list). Where there is a contradiction in terms between the clauses, phrases, words, stipulations, or terms and herein referred to generally as stipulations in this RFQ and the stipulations in any other document attachedhereto, or the RFQ submitted hereto, the relevant stipulations in this RFQ shall take precedence
- 2.2.2 Where this RFQ is silent on any matter, the relevant stipulations addressing such matterand which appear in the PPPFA shall take precedence. 



The envisaged solution must provide a centralized, Exclaimer cloud-based platform for managing professional email signatures across all the users within the Office 365 (Exchange Online) environment. The objective is to ensure consistency in corporate branding, regulatory compliance, and dynamic personalization of signatures via Azure Active Directory integration.

In addition to providing the required Exclaimer licenses, the service provider is also required to:

- 1. Installation, setup and configuration of the Exclaimer product including activation of all the appliable licenses.
- 2. Integration of the product with Microsoft 365 tenant and facilitate directory synchronization if so required
- 3. Apply and test sample email signature templates
